 - .01 Board of Directors elections of positions
 - Motion made by Dir. Currier to nominate Dir. Locatelli as Chairman of the Board. Seconded by Dir. Robustelli. Vote was unanimous. Motion carries.
 - Motion made by Dir. Currier to nominate Dir. Presswood as Vice Chairman of the Board. Seconded by Dir. Locatelli. Vote was unanimous. Motion carries.

 - .03 Procedure for filling the open directors position
 - Chief Bingham explains to the Board the procedure needed to be done in order to elect a new board member. He gathered information from Santa Cruz County Elections Department and has provided all documentation needed.
 - Dir. Locatelli asked for clarification on the procedures needed to be done in order to appoint a new member. This individual will hold the position until the next General Election in November of 2024.

All agreed posting around town will help bring in more applicants.
